3. The 50% subsidy of stall rental reimbursement for participating in national/International ICT Exhibitions/Conferences/Events, as per the ICT Policy, would be made available to such eligible ICT companies, as per the following terms and conditions:

- The subsidy is available only to the ICT companies as mentioned in the ICT Policy 2010-2015.
- Prior intimation shall be given by ICT companies of the State to the IT&C Department before participation in the national/international ICT Exhibitions as mentioned in Para 2 above.
- Reimbursement of 50% subsidy on the cost of stall rentals would be limited to stall space rental cost for 9 sq. mts.
- Proof of participation and copy of invoice should be submitted to Department of IT&C for reimbursement after the event.

- The ICT Company will file a report on its participation, including business generated thereon.
- The incentive is available to ICT Companies based in AP only.
